### Influenza Season is Right around the Corner

The 2023-2024 flu season is upon us and it's time to start vaccinating patients to prevent severe infection. The CDC recommends that the ideal time to vaccinate most patients is in September or October, but patients still benefit from vaccination at any point during the influenza season.

#### Influenza in Long-Term Care

Influenza season can be particularly challenging in the long-term care setting given most patients are at high risk of both contracting infection and severe disease. The CDC provides specific resources to support long-term care facilities in navigating flu season, which addresses vaccination, infection prevention measures, and outbreak management to help health care providers protect patients.

#### **Big Strides for HIV Treatment**

The SOLAR randomized controlled trial recently published results!<sup>1</sup>



- Enrolled patients with HIV who were already virally suppressed on the oral bictegravir-based tablet regimen
- Randomized patients to either continue tablet regimen or switch to the long-acting injection
- Injection was non-inferior to tablet in terms of efficacy at 1 year
- Overall, more adverse events were seen with the injection, but this
  was due to injection site reactions which often lessen with
  subsequent injections
- A preference questionnaire at the end of the study showed patients thought the long-acting injection was more convenient, discrete, and did not serve as daily reminder of HIV status unlike the pills.

Given the promising results in this trial and others, healthcare professionals will likely care for more patients on long-acting injectable HIV medications in the future. It will be important for institutions to have a plan for reconciliation and acquisition of this novel regimen to ensure successful transitions of care.
